1. There is **NO** discount, refund, or other allowance for absence, illness, vacation, holidays, school closures, or any other reason.
2. Parents/Guardians will be required to give **two weeks written notice** to terminate enrollment submitted to the school. Parents/Guardians will pay tuition for the two week notice period, even if the child does not attend the school during those weeks.
3. School operational hours are Monday-Friday 6am-6pm (with the exception of school holidays and closures listed on our academic calendar). Families picking their children up after these hours, or outside of their scheduled hours, will be assessed a late fee of **\$3.00 per minute** to compensate staff members if they have to stay late with your child.
4. A **\$30 fee** will be assessed for all NSF checks or other forms of returned payment.
5. Talbot Park Baptist Preschool reserves the right to exclude any child from attendance temporarily or permanently, under any circumstances deemed in the sole purpose and exclusive discretion of the School, to be interfering with the health, safety, or educational development of the child or any other child(ren) or who conduct is unsatisfactory per our handbook. The school further reserves the right to deny continued enrollment, or re-enrollment, to any student the School reasonably concludes that the actions of the parents or guardian are inconsistent or in nonsupport of the educational environment or counterproductive to a positive working relationship between the School and the parents or guardians.
6. Tuition is due **2 weeks prior to each week registered to begin June th through August 21st September through June 15th.** A late fee will be assessed for any payment not received by the 15th day of each month. The late fee is \$25.00. Any student whose tuition has not been paid by the 25th of the month will lose their space unless other arrangements have been made with the Director.
